All booths set up and ready: 8:30 A. M.

Closing: 12:00 P.M.

Cost: \$25 per 8' by 8' booth (19 available), \$35 per 10' by 8' booth (10 available)
(booths will be marked off for your convenience)

Booth fee must be submitted with the application form. Booth fee checks should be made out to the **Volcano Community Association or VCA.**

Details: There will be NO Vendor PARKING in the main parking lot. Unload your things and park around the corner on the Old Volcano Road. All vendors' cars must be moved by 8:00 AM

Selection of booth location will be on a first come, first serve basis to preregistered crafters. Gates will open at 7:00 A.M. for vendor setup.

All items **MUST** be home made or home grown. Please no imports or resales. Bring your own tables and chairs.

Volcano weather can be cold and rainy. Please prepare for this by bringing jackets and tarps. The venue is an open court that has a roof. The tarps may help to keep out the wind or rain.

Please clean up your area before leaving the craft fair at the end of the day.
